1409.1 To approve urgent payments for January 2022

The Deputy Clerk told Councillors that the payment for water/sewage charges for Summerland toilets was an estimated bill. He hoped the bill would be reduced once a reading had been taken.

1409.6 To receive the Income Report for December 2021

Councillors had seen the Income Report, for a total of £20,785.59. Cllr Lawton asked what the payment from the DEFRA Rural Payments scheme represented and the Deputy Clerk told Councillors that he would need to clarify how many years' grant this covered and whether any was retrospective. He also commented that the refund of water charges of £1,309.60 was the promised refund following the water leak discovered in The Parade.

The Chair said the Income Report was noted.

The Deputy Clerk explained that the Agenda had been kept very short following Government advice about Meetings. January's Amenities and Environment Committee Meeting had been cancelled but the Full Council Meeting would take place as usual on 25 January. Council should be encouraging the minimum of attendees only and agendas kept as short as possible.
