244.1 To approve urgent payments for December 2022 Payments 1-6, totalling £36,098.27, including £22,285.90 staff salaries

Cllr M Palmer queried the water/sewage charges for Blenheim Gardens. The Deputy Clerk told her that MTC adopted the existing sewage arrangements when it took over these public toilets. They are used regularly but in need of repair – the unisex toilets were permanently open and the gents toilets open for busy events. Cllr M Palmer felt the toilets needed maintenance. She also queried item 12. The Deputy Clerk told her that there was a stand-pipe next to Argos and the Lighting Company in The Parade. This was heavily used during the very hot summer.

The Deputy Clerk said details of the Council Tax base had yet to be received from SWaT but were expected prior to the next Full Council meeting. Further discussion was deferred until the Full Council meeting on 13 December to allow more in-depth discussion then when the Council Tax base would be known.
