#### 1117 TO AGREE THE SCHEDULE OF MEETINGS FOR 2021/22

Councillors had seen the proposed Schedule of Meetings for the Council year 2021/2022. The Clerk said she and the Deputy Clerk had discussed at length the possibility of hosting the Annual Town Meeting and had done desk-top risk assessments for face-to-face meetings. In view of the fact that restrictions were still in place and Council would struggle to handle public admission to limited space at the Community Building they felt that they had to advise Councillors to postpone any Town Meeting and possibly also the Full Council meeting scheduled for 25 May 2021. These, legally, would have to be face-to-face meetings. The Clerk said she was awaiting further guidance on holding meetings after Zoom meetings permission ended.

In reply to a question from Cllr Venner, Ms Rawle said there was no legal requirement to convene a Town Meeting, merely that if held it had to be between 1 March and 1 June. The Deputy Clerk said he thought few organisations would have much to report at a Town Meeting as, owing to COVID, not much had happened during the previous year. He said there was an Annual Report from the Mayor, presently in draft form, which he would be sending to any Councillors who wanted it. He was concerned there would be public criticism of Council if it arranged in-person meetings before 21 June.

Cllr M Kingston-James said he had had much experience of arranging gatherings during COVID restrictions for over a year and the safety aspects were very important. Risk assessments were needed for each event, marshalling of the public, social distancing rules

followed and ensuring members of the public were attending in their individual bubbles made public gatherings very difficult.

Cllr Rose said she could see no reason why meetings should not go ahead as most people had been vaccinated.

# 1121 TO DISCUSS THE CREATION OF A VISION STATEMENT FOR THE COUNCIL AND REVIEW OF THE TOP TEN PRIORITIES

The Clerk said that some of Council's Top Ten Priorities were no longer relevant as they had been achieved in the previous twelve months. This made it a good time for Councillors to think about a Vision Statement for MTC and where they would like to see Council in, say, five years' time. This would be a good exercise and useful to think about it in the context of the unitary reorganisation.

Cllr Lawton proposed adding "in conjunction with partners" to the present Priority 10. She was also anxious about the amount of abuse the area had suffered from, such as littering and bonfires and was keen to protect Minehead's part of the coast and National Park from this abuse. Cllr Lawton suggested a priority "To protect and enhance our immediate environments especially in relation to the coast and the National Park and its environs." Cllr Venner also wanted stronger and more equal partnerships with outside organisations such as the County and District Councils, the new authority, the Chamber of Trade and Minehead BID. He thought this should be a priority in its own right, for the benefit of the town. Cllr Bolton wished to have a priority of supporting social mobility (including improving transport links) in Minehead for both the younger and older generations and any initiatives which encouraged tourism to the town. Cllr Bloomfield suggested changing priority 7 slightly

to include enabling better Wifi. Other suggestions included supporting any initiatives encouraging job creation.

The Deputy Clerk said he and the Clerk would remove the priorities already achieved, reword the suggested new priorities and also give new Councillors who would be joining Council their opportunity to make suggestions. These would then be drafted and circulated for consideration and brought back to the next Full Council Meeting.

The Mayor thanked residents for attending who were watching on Facebook.

The Meeting closed at 8.40 pm.
