We are the people an income eligible **mother** of two talks to about her children's eating habits and leaves with information and checks or vouchers to purchase nutritious food items for those children to develop to their fullest potential.

We are the people a **couple** struggling to pay their water bill turns to as one would turn to your family for a listening ear and guidance. Having no family supports in the area, suffering a loss of income from an injury and depleting meager savings to maintain the mortgage, the couple receives guidance on applying for HEAP and a sense of relief that the water bill will be paid via the Emergency Assistance fund.

We are the people in the schools and after school programs educating the **youth** on staying drug free and how not to be a bully, helping them to make healthier choices now that will lead to their own success in the future.

We are the people a **grandfather** receives answers from on how to enroll his newest housemate, his grandson, into school as well as what forms he needs to seek medical records and to have the ability to make medical decisions in the absence of the biological parents. We are also the people he shares his worries and concerns on raising a child in today's world as it is very different than when he raised his son.

We are the people the **community**, of all races, creed, religions, and lifestyles turn to and receive help from.

We are one of fourteen agencies within Catholic Charities of the Diocese of Albany, one of the largest, private social services organizations in the region. We serve and empower all persons in need, regardless of race, creed, religion, or lifestyle; advocate for a just society; and collaborate with women and men of goodwill.

Last year we served 12,686 individuals within our two counties. We are Catholic Charities of Columbia and Greene Counties and we are here to serve, empower and advocate for you or your neighbors in need.

SNAP to it!

SNAP is the new name for the Food Stamp Program in New York State. The Supplemental Nutrition Assistance Program (SNAP) is designed to help families and individuals purchase the foods necessary for a healthy lifestyle. The average benefit a participating senior (60+) receives is currently \$150/month. A family of 4 could potentially receive up to \$668/month. The benefit amount is based on a client's income relative to expenses. SNAP benefits are easily accessed using an Electronic Benefits Transfer (EBT) card, which is similar to a debit card.

At both our Hudson and Catskill offices, Nutritional Outreach and Education Program (NOEP) Coordinators are here to assist consumers in applying and recertifying for SNAP benefits. Free and confidential "prescreening" is available to determine program eli-

gibility. At our Hudson location, Lynette Livermore serves as the Columbia County NOEP Coordinator, and may be reached at 828-8660. Marcella Schumann serves Greene county residents, and can be reached in the Catskill office at 943-1462. In the last 18 months, Catholic Charities of Columbia and Greene Counties has helped over 500 households to apply for SNAP benefits, bringing over \$2,080,512 of spending dollars to our counties.

Together We Can HELP Make a Difference

Catholic Charities of Columbia and Greene Counties is a founding and active member of Helping Everyone Live Post Disaster (H.E.L.P.) for Columbia and Greene Counties. This long term recovery group was formed in response to the unmet needs of victims following the flood disaster resulting from Tropical Storms Irene and Lee in August 2011.

HELP's mission statement reads; "H.E.L.P. for Columbia and Greene Counties is dedicated to being good stewards, to facilitate disaster recovery, simplify access to resources and to advocate for those most vulnerable." Currently the group focus is on eliminating the continuing unmet needs as a result of Tropical Storms Irene and Lee, and also to remain in place as a formal entity to be a resource for future disasters.

Despite the fact that HELP has a small handful of committed members, feedback from national organizations with experience in long term recovery group development has been extremely positive and encouraging. HELP has worked closely with national organizations such as The Red Cross, FEMA and religious volunteer organizations and groups such as UMCOR and the "Greene Shirts". It is with confidence that HELP can say that organizations has been impressed and praised the group on their development, progress and commitment.

As of February 2013, HELP and Catholic Charities of Columbia and Greene Counties have provided disaster assistance to over 35 seniors, 100 adults and 90 children. Subsequently numbers will continue to increase as residents are still recovering from Irene and Lee and several new requests have been made as a result of Hurricane Sandy. With continued support of the community, HELP along with Catholic Charities of Columbia and Greene Counties will remain viable resources for disaster recovery.



WIC Celebrates Dental Health Month

WIC (Women, Infants, and Children) is one of the nation's premiere public health programs. WIC serves pregnant women and families with children under five. WIC provides a safe, nurturing environment for education, health care and social service referrals, as well as free access to nutritious foods. On average, families come to our office four times a year for services. Twice a year we obtain clients heights, weights and screen for

anemia. Our goal is to assess what the client's primary health concerns are and help them make a tionists, we always are plan to change for the better. One topic that comes up in conversation is dental health. Dental health is important to everyone's overall good health. The WIC staff in conjunction with local dentists focused on this topic for the month of February, specifically about caring for teeth during pregnancy and early in a child's life. We discussed the advantages of fluoride for protecting teeth. Staff encourage families to come up with

a plan that fosters good dental habits for the whole family. As nutrigiving dietary tips to prevent dental cavities. We also refer families to dentists in the area. Greene Pediatric Dentistry, in Catskill, and All Access Dental, in Germantown, donated giveaways and informational handouts for our families during the Chatham, Copake Falls, month of February. Free toothpaste provided by Crest and toothbrushes provided by Colgate were given to all WIC families at their scheduled appointments in February. Thanks to Columbia Me-

morial Hospital's Dental Health Services, free dental screenings were offered to adults and children in the Catholic Charities' Hudson and Catskill offices for two days as well. The WIC program services clients regardless of county residence, with main offices in Catskill and Hudson. Five additional locations include Coxsackie, Valatie, and Windham.
