Summer Program: This is the 4th year we have offered this program to help close the gap of students who missed instruction during Covid and needed additional instructional time in reading and math to be able to meet the standards of the upcoming grade level for the 23/24 school year. This is being funded through ESSER. We have 10 groups of students that are invited this year in K-4.

Testing

<u>Test Results:</u> We have completed the end-of-year assessments on all grade levels. The state-mandated tests include STAR for K-2 and FAST for 3-5, and the school-selected blended learning diagnostic and instructional program is i-Ready. All of these tests are administered across several progress monitoring periods to determine if students are performing below, on, or above grade level and measure academic growth throughout the school year, as well as from year to year in the areas of Math and Reading. This is the second year that STAR / FAST and i-Ready diagnostic tests have been administered. Performance on PM3 of FAST is what determines school grade.

The FAST results below indicate the percentage of overall proficiency by grade and subject for the third assessment period (PM3) as compared to the DCPS district averages. Students are assessed on grade-level benchmarks, which they are expected to become proficient in by the end of the school year. The scoring scale has been adjusted as of PM2 of this year, so historical comparison of scale scores is not possible. However, percentage of proficiency for the past two years has been included.

In all areas but two, Seacoast averages exceed the Duval County averages. Additionally, all areas except one exceeded 50%, which is a marked improvement over previous years. The lowest performing area was 5th grade math, which was anticipated due to the low performance of that same group of students in 4th grade last year. However, in comparison to last year, that class of students was able to make considerable growth. Growth in all areas can be contributed to intentional teacher preparation, instructional coaching, and targeted student intervention of problematic deficiencies. The overall average proficiency for all tested areas this year is 54%, which equates to a school grade of "B".

On the STAR test, the average Percentile Rank scores indicate where Seacoast students rank compared to other students in the same grade nationally. The goal is to achieve at least the 50th percentile, which is considered adequate grade level placement. The table below shows average scores from the final progress monitoring period last school year (22-23) as compared to the three progress monitoring periods this year (23-24), so that trends in student progress from one grade to the next might be noted.

1st grade's drop in average percentile in reading can be partially attributed to the mandated switch to STAR Reading rather than STAR Early Literacy for the third progress monitoring period. However, that 1st grade group of students is showing a notable improvement in both reading and math over last year's averages. All three grade levels report below-average scores in reading, though it should be noted that our ELL population has grown substantially this year, particularly in the primary grades. It is for this reason that additional efforts to further support the ELL population will be put in place for the start of the 24-25 school year. 1st and 2nd grade math achievement is reportedly average.

I-Ready is the blended-learning program that the school has adopted. I-Ready is a <u>research-based</u> program with an individualized plan for instruction based on each student's performance on the i-Ready Diagnostic test. Diagnostics are given at least two times per year to determine students' instructional levels and specific areas of remediation in Reading and Math. I-Ready tests produce both scale and percentile scores that can be used to find correlations between scores achieved on the state-mandated tests and project student growth. The table below indicates the percentage of students who scored on or above grade level on the final diagnostic assessment last school year (22-23) as compared to the last diagnostic assessment this year (23-24). Also noted in the last column is the average amount of growth achieved toward students' annual growth targets.

The i-Ready system provides resources and recommends strategies for intensive intervention for the students who are performing below grade level. The growth targets are determined by the system after the initial diagnostic, and each student's individual growth target is reflective of how much they need to grow in order to achieve one year's growth. As indicated by the data in the table above, though some areas (such as 2nd grade math) are performing below grade level, students made outstanding progress towards growth targets. This is indicative of closing gaps in foundational knowledge, and we should see significant progress towards achieving grade-level standards for those students next year.
