AGENDA ITEM #4A – FINANCE REPORT, BUDGET

Monthly Financials and Mid Year Budget for 2025-2026 school year was presented to the Board. Mr. Modlin went over the budget with the Board with minimum enrollment, staffing, salaries, expenditures, grants, and any additional questions. In addition, December financials showed a net income increase from November by \$201,860.52. This was mainly due to receiving the mileage of \$267,621.85 Motion to accept by Charlie Schmitt, and second by Angel Gastfield. The Board approved.

AGENDA ITEM #4B – ADMINISTRATOR’S REPORT

Admissions & Enrollment: We continued to enroll students since the school year started. Maximum enrollment is 478 and we are currently at 427 with 31 students in VPK.
