Legislation Update

Lt. Governor Dan Patrick released committee assignments for the 88th Legislative Session, appointing Senator Drew Springer to six additional committees & as Vice Chair on two.

Senator Springer says, "I'll work with my fellow Senators on legislation to drive the TX Miracle, support schools while empowering parents, protect resources, limit overreaching regulations, & preserve TX values".

Senator Phil King was appointed to serve as Vice Chair of the Business & Commerce Committee and to serve as a member of the Border Security, Criminal Justice, Transportation and Education committees. King will also serve on the Higher Education Subcommittee of the Education Committee.

Senator King said, "I'm especially excited about the opportunity to serve as Vice Chair of the Business and Commerce Committee. For Texas to continue leading as an economic powerhouse, we must ensure an environment of limited, streamlined regulations and low taxes that promotes commerce, innovation and opportunity. This committee is also charged with correcting critical problems facing Texas' electric power grid, a topic I spent a great deal of time on in the Texas House."

Representative Glen Rogers shared with us- "We are ramping up for a productive session and awaiting House committee assignments. It takes longer in the House than Senate for committee assignments due to having almost 5x more members. Speaker Phelan is tasked with meeting with 149 house members individually prior to appointing members to the 34 House committees. Members usually serve on two committees. God Bless Texas!"

We have many critical issues we are staying in top of and will continue to keep our PCRW informed.
