

REGULAR MEETING
MARCH 11, 2024

THE MEETING WAS CALLED TO ORDER AT 6PM BY MAYOR
KILLINGSWORTH. PRESENT WERE ALDERMEN SLAGLE, MIZE,
JARVIS, SMITH, TURBEN, AND WAHL. ABSENT WAS ALDERMAN
ROBERTS.

ALDERMAN JARVIS MADE A MOTION TO APPROVE THE MINUTES
FROM FEBRUARY, A SECOND CAME FROM ALDERMAN WAHL. THE
VOTE WAS:


