AN ORDINANCE PROVIDING FOR THE CALLING OF A MUNICIPAL ELECTION TO BE HELD APRIL 8, 2025 TO ELECT CITY OFFICERS

BE IT ORDAINED by The Board of Aldermen of the City of Pierce City, Missouri as follows:

Section 1: There is hereby ordered by the Board of Aldermen of the City of Pierce City, Missouri, a municipal election to be held April 8, 2025 for the purpose of the election of City Officers.

Section 2: The Officers to be elected:

First Ward Alderman – 1 two year term

Second Ward Alderman – 1 two year term

Third Ward Alderman – 1 two year term

Fourth Ward Alderman – 1 two year term

Section 3: Voting shall be at the Barry/Lawrence County Library, 101 N. Walnut in Pierce City, Missouri, unless notified otherwise by County Election Official.

Section 4: All polls open at 6:00 am and close at 7:00pm.

Section 5: All candidates for the above mentioned offices shall file their names in person at the City Hall during normal posted business hours with the filing fee commencing December 10, 2024 and not later than December 31, 2024 at 5:00pm.
