AN ORDINANCE AMENDING CITY CODE SECTION 400.010 REGARDING COMPOSITION – TERMS – VACANCY – REMOVAL

WHEREAS, the Board of Aldermen for the City of Pierce City, Missouri wish to amend City Code 400.010

BE IT ORDAINED BY THE BOARD ALDERMEN OF THE CITY OF PIERCE CITY, MISSOURI AS FOLLOWS:

SECTION ONE: This ordinance amends Code 400.010

SECTION TWO: The previous Code 400.010 is amended. The new Code 400.010 shall read as follows:

SECTION 400.010 COMPOSITOIN -- TERMS -- VACANCY - REMOVAL

There is hereby established within the City a Planning and Zoning Commission which shall consist of not more than fifteen (15) nor less than seven (7) members. One member will come from the Board of Aldermen and be selected by the Board. Not more than fourteen (14) nor less than six (6) citizen members shall be appointed by the Mayor and approved by the Board of Aldermen. The term of each of the citizen members shall be for a four (4) years, except the terms of the citizen members first (1st) appointed shall be for varying periods so that succeeding terms will be staggered. Any vacancy in the membership shall be filled for the unexpired term by appointment as aforesaid. The Board of Aldermen may remove any citizen member for cause stated in writing and after public hearing.

SECTION THREE: This ordinance supersedes and revokes any provisions of past ordinance(s) inconsistent with the provision of this ordinance.

SECTION FOUR: This ordinance shall be in full force and effect from the date of its passage and approval.

AN ORDINANCE AMENDING CITY CODE 715.050 BILLING- TO SET DUE DATE AND ADDING A \$25.00 RECONNECT FEE

WHEREAS, the Board of Aldermen for the City of Pierce City, Missouri wish to amend City Code 715.050

SECTION 715.050 BILLING - WHEN DUE

- A. All users shall be billed monthly. All water bills are due the twenty-first day of the month, and all accounts not paid in full by the first day of the following month will be disconnected. There will be a twenty-five dollar \$25.00 reconnect fee to have water service reconnected.
- B. Late payment penalty of two percent (2%) of the user charge bill will be added to each delinquent bill for each thirty (30) days of delinquency.

SECTION THREE: This ordinance supersedes and revokes any provisions of past ordinance(s) inconsistent with the provision of this ordinance.

SECTION FOUR: This ordinance shall be in full force and effect from the date of its passage and approval.

AN ORDINANCE AMENDING CITY CODE 710.050 BILLING-TO SET DUE DATE AND ADDING A \$25.00 RECONNECT FEE

SECTION 710.050 BILLING - WHEN DUE
