

REGULAR MEETING

MAY 12, 2025

THE MEETING WAS CALLED TO ORDER AT 6:00PM BY MAYOR KILLINGSWORTH. PRESENT WERE ALDERMEN SMITH, WAHL, JARVIS, ROBERTS, WEBB, HEAD AND SOOTER.

ALDERMAN WAHL MADE A MOTION TO ACCEPT THE RESIGNATION OF ALDERMAN SLAGLE, A SECOND CAME FROM ALDERMAN ROBERTS. THE VOTE WAS:

SMITH: YES WAHL: YES JARVIS: YES ROBERTS: YES
WEBB: YES HEAD: YES SOOTER: YES

ALDERMAN JARVIS MADE A MOTION TO APPROVE THE MINUTES FROM APRIL, A SECOND CAME FROM ALDERMAN WAHL. THE VOTE WAS:

SAFETY TO BE USED FOR POLICE PUT ON THE AUGUST BALLOT.
