ORDINANCE # \_\_\_\_\_

An ordinance amending City Code 117.060-Age by adding the age required to be a police officer.

WHEREAS, the Board of Aldermen for the City of Pierce City, Missouri wish to amend City Code 117.060-Age

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PIERCE CITY, MISSOURI AS FOLLOWS:

SECTION ONE: This ordinance amends City Code 117.060

SECTION TWO: The new City Code 107.060 shall read as follows:

The minimum age for employment as a probationary employee shall be eighteen (18), unless the Mayor shall, in writing, waive the requirement. The minimum age for employment of seasonal employees shall be fifteen (15) years of age. The minimum age for employment of a police officer shall be twenty-one (21).

SECTION THREE: This ordinance supersedes and revokes any provisions of past ordinances inconsistent with the provisions of this Ordinance.

SECTION FOUR: This ordinance shall be in full force and effect from the date of its passage and approval.
