RESOLUTION 26-1 WAS READ BY TITLE

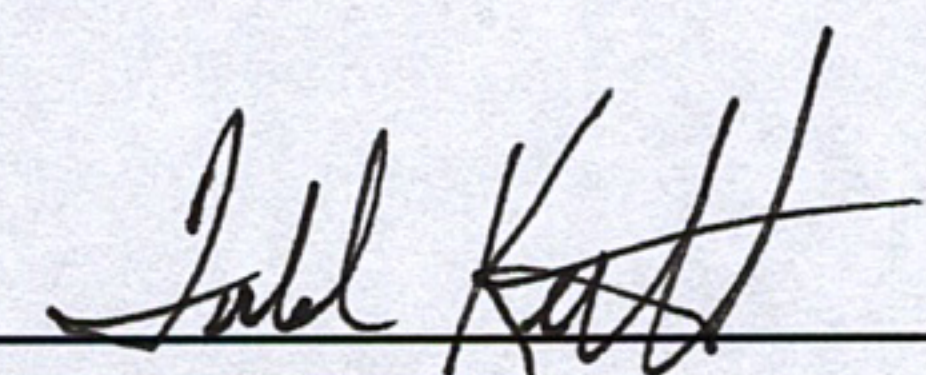

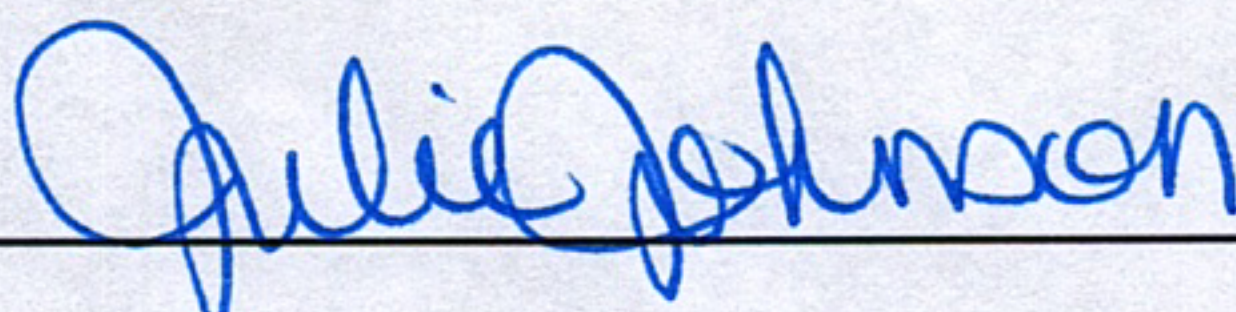
