





Understand and Assess Al Tools

Conduct evaluations before implementation AND Ensure legal and ethical standards.



Interdisciplinary Collaboration

Collaborate with Al experts, data scientists, and ethicists. Foster interdisciplinary communication.



Data Governance and Bias Mitigation

Establish data handling, storage, and access policies. Use accurate, secure, unbiased data. Regularly audit and mitigate biases.



Transparency and Explainability

Use tools with clear decision-making processes. Maintain documentation of Al decisions.



Continuous Education and Training

Keep professionals updated on Al developments. Provide ongoing ethical training.



Regular Policy Review

Evaluate and update Al policies continuously. Adapt strategies to new advancements and regulations.
