

The details concerning my brother Lyle (not his real name) are not privy on our websites until he is 18 years old and gives his permission. What we have put on our websites are the issues that affected my protection and had the potential to risk it again, even after there was a No Contact Order on my parents.

Dr. Leibel's and Dr. Ruthnum's reports that discredited my grandma and slandered her also discredited my experiences and accounts of what happened.

Their positions had the potential for my siblings to be put back with my abusers and even had the potential to. Justice Dickson believed me and I am so very grateful for that.

The following concerns are documented below by my grandma. -Charlene

The diagnosis of my daughter, Destiny, as having Multiple Personality Disorder (MPD) that Des received from Dr. C. Smith (Clinical Psychiatrist) and affirmed by Dr. Colin Ross (Clinical Psychiatrist) has been ignored. Ms. Bisskey told me that the department would never believe that Des had MPD.

Nor did they believe that Charlene has PTSD but stated that I simply I was mistaken in observing her as she was likely "only acting out" which was within normal parameters, as stated by one of my Protection Workers, Ms. Sharon Deitner, who documented this in a letter she authored to Dr. P. Matthews. noted in the Affidavit of Part Two for this lawsuit.

Dr. S. Leibel's letter of July 17<sup>th</sup>, 2003 entitled CHILD & FAMILY MEDICAL CONSULTATION REPORT is much along the same lines as Dr. Ruthnum's in which **Arlene Lowery continues to be their target.**

On page 1 paragraph 1 line 7 ...:

The social worker says ..... There have been charges of **attempted murder against Damian by his brother.** This charge was dropped because Destiny refused to testify. ....

line 18-25 **The charges were dropped against Destiny... However, since that time Arlene Lowery has had a fixed semi-delusional idea that Destiny was involved with a satanic cult of child abusers who not only molested children but may have killed babies as part of their rituals. Arlene Bisskey, Child Protection Worker, mentions that Arlene Lowery is reasonable and stable on all other points and is a good caregiver for the three older kids. However Arlene Lowery does not seem to be very rational when discussing her belief that her adoptive daughter is a satanic child molester.**

Then Dr. Leibel reinforces the above on page 2 paragraph 2. line 2. where Dr. Leibel is making a case for Des's husband: She writes:

"She (Destiny) has longterm involvement with legal husband Damian ----, who has a history of severe domestic violence and **nonfamilial violence but no history of child molestation or sexual impropriety.** He does however come from a family with a history of sexual molestation. **He is banned from contact with his children.** .....

**Destiny's adoptive mother ..... has an unshakable conviction that her daughter is a satanic child molester but is otherwise reasonable and rational on other points. Is convinced that Lyle has been sexually abused by Destiny or some of her contacts despite minimal and primarily supervised contact of Destiny with Lyle only.**
