CONSULTATION REPORT

CHILD AND FAMILY MEDICAL SERVICES CLINIC

Charlene Dobson is a 4 year-old child who was seen in the Child and Family Medical Services Clinic on April 14, 1997. She had revealed to her grandmother that her mother, Melinda, and her mother's boyfriend had been touching her potty (which is a term she uses for her genital area). She also revealed to her grandmother that her mother had burned her with a hot knife on several occasions on her body. Charlene has been seen previously in the Child and Family Medical Services Clinic in December, 1996 when there was an accusation against her biological father. She was also examined at that time. Charlene came with her maternal grandparents, Chuck and Arlene Lowry, and they were accompanied by Debbie Ferguson from Regina Police Services. Apparently Charlene's mother, , has a problem with drug abuse and also has been into the occult, and there is some concern that some of the abuse may be part of an occult ritual.

When I examined Charlene, examination of head and neck was normal. Chest was clear. Heart sounds were normal. She did have a grade I/VI systolic murmur at the left sternal border, probably functional. Abdominal examination was normal except for two small scars. She had several scars over her body and I will list these here: First, there was a deep, old scar on her right hand, 2cm. long over the dorsal surface of the hand and then 1cm. going down the fourth finger. Charlene could not remember what had happened. When I talked to her grandmother she said that this had occurred at the grandmother's house on a curling iron a couple of years ago. Also, she had a number of small scars that were very similar in appearance. They were slightly scaly but about the same age. There was one on the dorsum of her left hand, one on the left mid abdomen, one on her right lower abdomen, and one on her left back. There was also one on her left upper leg. These scars looked fairly similar in shape and in age. When I asked Charlene what had happened she said her mother had hurt her with a knife, and she said it was a hot knife. There is also another midline, old scar on her back. There were linear scars on the back of both legs and a small scar on the right lateral malleolus and left medial malleolus. These are very suggestive of ligature marks. There is also a small scar on the posterior part of the left elbow; this looked old. On vaginal examination, there did appear to be a cleft in the posterior hymen. Pictures were taken and will be compared with pictures from previous examination. Swabs were done for Chlamydia, Gonorrhoea and C&S.

These findings are certainly very concerning and with the history would raise grave concerns regarding physical and sexual abuse. Charlene currently has no contact with her mother and is in the care of her grandparents.
