Re: Arlene Lowery v. Government of Saskatchewan et al File No. 33944

Further to the matter of the sealing of portions of this file, **I** can advise that the initial Queen's Bench Order, which has not been impugned or overturned (see correspondence of November 19, 2010 that addresses this issue), was sought so that the plaintiff's provision of purported adoption, child protection and patient-client information throughout her materials and relating to a number of individuals who are not parties to the action, (many of them being under the age of majority), would not be made publicly available without good and sufficient reasons. It has now been confirmed that the Saskatchewan Court of Appeal did not seal its file due to a practice that was not known by this office until very recently. While there are no provisions in the Saskatchewan Court of Appeal Rules or *The Court of Appeal Act* addressing applications for sealing a file, the practice there is apparently not to seal the file on the basis of the lower court Order alone.

Page 3 excerpt: As sealing the file does not impact the Government of Saskatchewan directly we will not be bringing a motion, however it may well have an impact on those individuals who are not parties but have been identified in the materials. We therefore simply draw this to your attention for the exercise of any discretion you may consider advisable.
