The Buyer understands that no kitten will leave Mainer Mici Bengals until full payment has been received.

DEPOSIT POLICY

Deposits are **NON-REFUNDABLE**.

Deposits may only be transferred to another litter at Seller's discretion.

If Buyer changes their mind, fails to complete payment, or cannot take possession of the kitten, the deposit will be forfeited.

Seller reserves the right to refuse a sale at any time if Seller believes placement is not in the best interest of the kitten. In such cases, deposits may be refunded at Seller's discretion.

HEALTH GUARANTEE

Seller guarantees that the kitten is in good health at the time of transfer.

THE KITTEN WILL LEAVE:

- Age appropriate vaccinated
- Dewormed
- Examined by a licensed veterinarian
- Free from visible signs of illness
- Socialized in a home environment

Buyer agrees to have the kitten examined by a licensed veterinarian within 72 hours of receiving the kitten.

IF A LICENSED VETERINARIAN DETERMINES THE KITTEN HAS A LIFE-THREATENING ILLNESS EXISTING PRIOR TO TRANSFER, BUYER MUST:

- Notify Seller immediately
- Provide written veterinary documentation
- Return the kitten if requested by Seller
- Seller reserves the right to obtain a second veterinary opinion.

IF A QUALIFYING HEREDITARY OR CONGENITAL CONDITION CAUSES DEATH WITHIN:

- 2 year from purchase date

SELLER MAY OFFER:

- A replacement kitten when available
- OR
- Partial refund at Seller's discretion

THIS GUARANTEE DOES NOT COVER:

- Stress-related illness after transfer
 - Parasites, coccidia, giardia, or upper respiratory infections
 - Reactions to vaccines
 - Hypoglycemia due to poor feeding
 - Illness caused by exposure after leaving Seller
 - Injuries or accidents
 - Heat stroke, poisoning, or neglect
 - FIP (due to current veterinary uncertainty regarding cause)
 - Any condition caused by failure to provide proper veterinary care
 - Spay/Neuter Agreement

Buyer agrees that kitten is spay/neuter before they leave Mainer Mici Cattery

INDOOR HOME REQUIREMENT

Buyer agrees this kitten will be:

- Kept primarily indoors
- Never abandoned, surrendered to a shelter, or released outdoors
- Buyer understands Bengal cats are highly active, intelligent animals requiring:

DAILY INTERACTION

- Mental stimulation
- Proper exercise
- Appropriate climbing and enrichment
- Declawing Prohibition
- Buyer agrees NEVER to declaw this kitten.

Declawing is considered inhumane and a violation of this Agreement.

IF BUYER DECLAWS THE KITTEN:

- Health guarantees become VOID immediately.

VETERINARY CARE

Buyer agrees to:

- Maintain routine veterinary care
 - Keep vaccinations current
 - Provide flea/tick prevention as recommended
 - Seek immediate veterinary attention when needed
 - Feed a high-quality diet
 - Failure to provide proper care voids all guarantees.

RETURN POLICY

If Buyer can no longer keep the kitten for ANY reason:

- Seller must be contacted **FIRST**.
- Seller will assist in rehoming when possible.

Buyer may NOT surrender the kitten to:

- shelters
- rescues
- pet stores
- research facilities

Seller does not guarantee refunds for returned kittens.

SHIPPING & TRANSPORTATION

If shipping or delivery is arranged:

- Buyer assumes responsibility once kitten is transferred to carrier or transportation provider.
- Shipping fees are non-refundable.
- Seller is not responsible for delays caused by airlines, weather, or transportation companies.

CLOSED CATTERY POLICY

For the safety of Seller's family, cats, and kittens, Mainer Mici Bengals maintains a CLOSED CATTERY.

- No home visits are permitted.

Buyer understands this policy exists to:

- Protect kittens from illness exposure
- Maintain biosecurity
- Ensure safety and privacy

SELLER MAY OFFER:

- Video calls
- Photos
- Virtual kitten visits
- Breeder Rights

SELLER RESERVES THE RIGHT TO:

- Refuse sale at any time
- Cancel this Agreement if Buyer is found unsuitable
- Retain any kitten longer if Seller believes it is medically necessary
- Limitation of Liability

SELLER SHALL NOT BE LIABLE FOR:

- Veterinary expenses
- Emotional distress
- Property damage
- Injuries caused by scratching, biting, or animal behavior
- Allergic reactions
- Any indirect or consequential damages
- Maximum liability shall never exceed the purchase price of the kitten.

BUYER ACKNOWLEDGEMENT

BUYER ACKNOWLEDGES:

- Bengal cats are energetic and demanding
- No guarantees regarding size, color development, or personality can be made
- Cats may experience stress during transition
- Proper introductions to existing pets are necessary
- Buyer confirms they have researched the Bengal breed and understand its needs.

ENTIRE AGREEMENT

This document represents the entire agreement between Buyer and Seller.

No verbal statements or promises are legally binding unless included in writing within this Agreement.

This Agreement shall be governed by the laws of the State of Maine.
